### TRIAGE PROGRAM DESCRIPTION

### How does it work?

Offices simplify their workflow to include only LMC requisitions. The office sends all specimens, regardless of type or insurance, to LMC for processing. Specimens are accessioned at LMC, and then triaged based on insurance/payer, test type and device. Only work that is "in-network" and that can be completed by LMC is processed by LMC. Any work that cannot be processed by LMC is sent to the proper lab based on insurance/payer information (provided by office/patient).

### Will my specimens be delayed?

No! Because the other labs (Quest, Labcorp and CPL) pick up these specimens directly from us several times a day. This ensures that your specimens are processed the same day at these labs resulting in zero delay in turn around as if send directly from your office.

# What if the specimen gets sent to the wrong lab?

In a traditional workflow, your office does the "triaging" to each lab. Patients tend to hold the physician's office responsible when specimens get incorrectly sent to a lab, therefore placing financial risk on the office. Our clients can rest assured that when all work is sent to us, we'll be responsible for proper routing. In the event we incorrectly route a specimen to the wrong lab, we will be responsible for that error.
